### NOTE: PROOF OF INCOME MUST BE INCLUDED

Crestwood Village Co-op Three welcomes those that have a desire to become residents of the Village. All local realtors are available to assist you and have a listing of all units available for occupancy.

Crestwood Village Co-op Three has the following process that all potential residents must follow:

- Crestwood Village Co-op Three will have an outside company perform a financial and background check of all applicants. We require a credit score of at least 740 and a minimum monthly income of \$1,700 to \$2,000 for each Prospective Purchaser depending on the model.
- Crestwood Village Co-op Three will conduct an interview of all applicants.

Prior to the start of this review process all applicants must complete the following questionnaire. The completed questionnaire must be submitted to the Village office along with a non-refundable check for \$50 made out to "Crestwood Village Co-op Three" and proof of all income must be included (Note: \$50 per occupant).

Be advised that at the time of a closing, the new resident will be required to sign a document stating that they have been provided with a copy of the Village By-Laws and that they agree to abide by all rules contained within.

BY SIGNING THIS APPLICATION EACH PROSPECTIVE MEMBERSHIP CERTIFICATE PURCHASER CONSENTS AND ACKNOWLEDGES THAT CRESTWOOD VILLAGE CO-OP THREE HAS THE RIGHT TO OBTAIN A CREDIT AND BACKGROUND REPORT FOR EACH PROSPECTIVE PURCHASER AND ALL PLANNED OCCUPANTS OF THE UNIT FROM A CREDIT/BACKGROUND REPORTING AGENCY APPLICABLE TO CRESTWOOD VILLAGE CO-OP THREE AT THE EXPENSE OF THE PURCHASER(S).
